Claim Adjustment/Reconsideration	Step 1: Utilize the chat feature within Availity. Access via Payer Spaces > Anthem > Applications > Chat with Payor
	Step 2: Contact Provider Services. Find the appropriate Provider Service number on the back of the member's ID card. Ask to speak to a Provider Service Supervisor/Escalation Agent.
	Step 3: Please submit through the <u>Claim Action Request Form</u> . The form is available online. Go to anthem.com , and select Providers . Under the Provider Resources heading, select Forms and Guides . Select Nevada if you haven't done so already. Search for "Claim Action Request".
	Request should be submitted to the Adjustment Address listed on the Prefix Reference List for the appropriate Member Type. Our Prefix Reference List is posted online. Go to anthem.com. Select Providers. Under Communications heading, select Contact Us. Select Your State, then select Prefix Reference List. If you have completed the steps above and the issue has not been resolved
